1. Introduction

This nomination bundle provides the comprehensive documentation required by the Sierra Leone Football Association (SLFA) Electoral Committee for individuals and representatives seeking to nominate candidates for the upcoming elections into the following elective positions: President, Vice President 1, Vice President 2, and three (3) Ex-Officio Members.

2. Nomination Criteria for Candidates

All prospective candidates must fulfil and submit evidence of the following:

Valid Police Clearance Certificate

Valid National Identification Card/Passport

Sworn Affidavit affirming eligibility, good character, and commitment to SLFA values

Attestation or Endorsement Letter from the candidate's Regional and District Football Association in line with the SLFA Statutes

3. Requirements for Nominating Members

Any Member wishing to nominate a candidate must be fully paid up and must also produce receipt from SLFA in support of membership fee paid for 2024 and 2025 company years.

4. Requirements for Nominating Officers

The officer acting on behalf of a nominating member must provide the following:

- Letter of Authority from the SLFA Member endorsing the nomination
- Certified Copy of Minutes of the Meeting where the Letter of Authority was approved
- The above meeting must be held within the official nomination period – i.e., 5th – 15th June, 2025

5. Candidature fee

The following mandatory candidature fees shall be paid by prospective candidate into SLFA account (004001096975120240) at UTB and proof of payment (SLFA receipt) submitted at the time of nomination.
